APPLICATION

COMES NOW Petro-Canada Resources (USA), Inc., a Colorado corporation, as Applicant, and respectfully submits this application to the Oil and Gas Conservation Commission of the State of Colorado. In support thereof, Applicant states as follows:

1. That the Applicant is duly authorized to conduct business in the State of Colorado.

2. That the Applicant is the owner of certain leasehold and working interests in the following described lands located in Weld County, Colorado, to wit:

Township 6 North, Range 66 West, 6th P.M.
Section 18: W/2SW/4

3. That the above-described lands have been included within the Wattenberg Field spaced area in Cause No. 407, calling for 80-acre drilling and spacing units for the production of gas and associated hydrocarbons from the Codell and Niobrara Formations which initial order the Commission has amended on numerous occasions but which provides for spacing on the basis of 80 acres with optional rights to drill infill wells within the Application area.

4. That the Applicant proposes to drill one well, the Dunbar 18-33, at a legal location as set forth in Rule 318A in the W/2SW/4 of Section 18 to the Codell and Niobrara Formations in the drilling and spacing unit affecting the lands described in paragraph 2 above. Although Applicant holds the significant leasehold interest in these lands, there are separate unleased mineral interests within the drilling and spacing unit which are held by the parties set forth on Exhibit A.

5. That said parties listed on Exhibit A have been offered the option to participate in the drilling of said well, but have to date refused to participate by granting a lease or by bearing their proportionate share of the costs and risks of drilling and operating the well. Upon refusal to execute an oil and gas lease, Authority for Expenditures ("AFE's") for the well were sent by Applicant by federal express to such parties on March 1, 2005, but to date they have refused to participate. Prior to the hearing on this matter, more than thirty (30) days will have elapsed since receipt of such AFE's. (See Exhibit B for copies of letters and attached AFE's.)

6. That in order to prevent waste, protect correlative rights and in the best interest of conservation, the non-consenting unleased interests set forth on Exhibit A should be pooled in the Codell and Niobrara Formations in accordance with Section 34-60-116, C.R.S. and Rule 530 of this Commission.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice thereof be given as required by law and that upon such hearing this Commission enter its order:

A. That the unleased mineral interests located on Exhibit A who refuse to lease or participate in the drilling of the proposed well in the Codell and Niobrara Formations within the above-described drilling and spacing unit be pooled, that such owners be treated as non-consenting owners under the referenced statute; and

B For such other further relief as this Commission deems just and proper.
