APPLICATION

COMES NOW Spoon Valley Energy, LLC, a New Mexico limited liability company authorized to do business in the State of Colorado ("Applicant"), by its attorneys, Poulson, Odell & Peterson, LLC, and makes application to the Oil and Gas Conservation Commission of the State of Colorado for an order pooling all nonconsenting interests for the drilling and completion of the Harry Willis No. 1 well located in NE/4 of Section 4, Township 29 South, Range 69 West, 6th P.M. in Huerfano County, Colorado (said described lands hereinafter referred to as "Application Lands"). In support of its application, Applicant states and alleges as follows:

- 1. The Application Lands constitute an approximate 160-acre drilling and spacing unit for the Dakota and Entrada Formations pursuant to the Commission's Order No. 520-1.
- 2. That the Harry Willis No. 1 well was drilled in February 1997 as a potential producer of principally gas (including CO2) from the Dakota and Entrada formations. Such well has been shut-in since it was drilled because it was uneconomic to make the gas suitable for marketing.
- 3. That gas from this well has now become marketable due to the construction of a facility which, when completed, will be able to separate the CO2 out of the gas stream.
 - 4. That the Harry Willis No. 1 well will now be completed for production.
- 5. That various unleased mineral owners (or their predecessors-in-interest) in the 160 acre drilling unit constituting the Application Lands did not participate in the drilling of the Harry Willis No. 1 well.
- 6. That these unleased mineral owners (who are more specifically identified on Exhibit "A" attached hereto) have been sent timely written offers allowing them to participate in the drilling and completion of the Harry Willis No. 1 well. As of the date hereof, these owners either elected not to participate in such drilling and completion (or to lease their interests) or have not responded to the correspondence from Applicant making such offers.

- 7. That Applicant now desires to force pool the interests of these unleased mineral owners pursuant to the provisions of Colo. Rev. Stat. ¶ 34-60-116.
- 8. That in order to prevent waste, protect correlative rights, and in the best interest of conservation, all unleased mineral owners listed in Exhibit "A" should be pooled in the Dakota and Entrada formations in accordance with Colo. Rev. Stat. §34-60-116 [including subsections (7)(b)(i) and (ii)].
- 9. That the names and addresses of the unleased mineral owners whose interests are to be pooled under this Application are set forth on Exhibit "A," attached hereto and made a part hereof.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing in January, 2006, that notice be given as required by law and that upon such hearing this Commission enter its order consistent with the Applicant's requests as set forth above.
