APPLICATION REQUEST FOR EXCEPTION LOCATION

Comes now SPYGLASS EXPLORATION, LLC, Applicant, and in support of this Application states and alleges as follows:

1. Applicant is the owner of Oil and Gas Leases covering the following described lands, to wit:

TOWNSHIP 30 SOUTH, RANGE 45 WEST, 6th PM

Section 30: ALL.

Baca County, Colorado

- 2. The Commission established 640 acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Topeka Limestone underlying certain lands in the Vilas Field on June 14, 1966 in Order No. 197-1, with the units to consist of a governmental section, and in the same Order, the Commission provided that the permitted well be located no further than 1200 feet from the center of the drilling and spacing unit upon which it is located. The subject lands are included in lands subject to Order 197-1. Subsequent Orders in the same Cause have been issued by the Commission, two of which have granted the Petitioner relief in the form of an exception location.
- 3. No wells have been drilled in the subject spacing unit. There are no productive wells in any offsetting spacing unit to the subject lands. Applicant requests the Commission grant approval of Applicant's request for an exception location in the NW/4NE/4 of Section 30-30S-45W, being more particularly described as being 624' FNL and 1552' FEL of said Section 30-30S-45W, Baca County, Colorado.
- 4. Applicant's engineering and geological studies indicate that the proposed location is the best location in which to encounter the thickest, most permeable reservoir in the Topeka Limestone in the most structurally advantageous location in the subject spacing unit. This Application, if granted, will provide for the best conservation of natural resources and prevention of waste, and provide protection of correlative rights in the drilling and spacing unit consisting of Section 30-30S-45W for production from the Topeka Limestone.
