APPLICATION

COMES NOW, Antero Resources Piceance Corporation ("Applicant"), a Delaware corporation, by its attorneys, Poulson, Odell & Peterson, LLC, and makes application to the Oil and Gas Conservation Commission of the State of Colorado for an order establishing well location and setback rules applicable to the drilling and producing of wells from the Williams Fork Formation and Iles Formation of the Mesaverde Group underlying certain described lands in the Mamm Creek Field area, Garfield County, Colorado and in support of its application states and alleges as follows:

1. That Applicant is a corporation duly authorized to conduct business in the State of Colorado.

2. That Applicant owns oil and gas leases covering a substantial portion of the following described lands (hereinafter "Application Lands"):

Township 6 South, Range 92 West, 6th P.M. Section 8: Lot 8, Lot 9, NE/4SE/4 and S/2SE/4

3. That the Application Lands are unspaced and subject to the Commission's Rule 318 (formerly Rule 316).

4. That pursuant to the Commission's Order No. 191-36 dated November 15, 2006, the Application Lands were authorized for ten acre density drilling of Williams Fork Formation wells and Iles Formation wells subject to certain specified setback requirements.

5. Due to problems in leasing unleased interests covering portions of the Application Lands, Applicant has found it necessary to request that the Application Lands be designated by the Commission as an approximate 195-acre drilling and spacing unit for the production of gas and associated hydrocarbons from the Williams Fork Formation and Iles Formation of the Mesaverde Group.

6. That as to the drilling and spacing unit consisting of the Application Lands, the Commission should allow all future Williams Fork Formation wells drilled thereon to be located downhole anywhere upon such lands but no closer than 100 feet from the outside boundary of the Application Lands unless such boundary abuts or corners lands in respect of which the Commission has not at the time of the drilling permit application granted the right to drill 10-acre density wells in which event the Williams Fork Formation wells to be drilled upon the Application Lands should be drilled downhole no closer than 200 feet from that portion of the boundary which so abuts or corners the lands in respect of which 10-acre density downhole drilling for Williams Fork Formation wells has not been ordered by the Commission.

7. Further, the Commission should allow Iles Formation wells to be optionally drilled on a ten (10) acre density basis with each such well to be located downhole anywhere upon the Application Lands provided that no such well shall be located downhole any closer than 400 feet to the outside boundary of the Application Lands, it being understood that the Iles Formation wells may be drilled only in conjunction with the drilling of the Williams Fork Formation wells.

8. That, except as previously authorized by order of the Commission, wells to be drilled under this Application will be drilled from the surface either vertically or directionally from no more than one pad located on a given quarter quarter section unless exception is granted by the Colorado Oil and Gas Conservation Commission pursuant to application made for such exception.

9. The granting of this application will not promote waste; will not violate correlative rights and will assure the greatest ultimate recovery of gas and associated hydrocarbon substances from the reservoir.

10. That the names and addresses of the interested parties according to the information and belief of the Applicant are set forth in <u>Exhibit A</u> attached hereto and made a part hereof.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing in July, 2007, that notice be given as required by law and that upon such hearing this Commission enter its order consistent with Applicant's proposals as set forth above.
