APPLICATION

COMES NOW Laramie Energy II, LLC (referred to herein as "Applicant"), by and through its undersigned counsel, and makes application to the Oil and Gas Conservation Commission of the State of Colorado ("COGCC"), for an order to pool all non-consenting interests for the drilling of wells in an approximate 320-acre drilling and spacing unit in the Williams Fork Formation and the Iles Formation in the lands more particularly described in Paragraph 3 below located in Township 6 South, Range 93 West, 6th P.M., Garfield County, Colorado. In support thereof, the Applicant states and alleges as follows:

1. That the Applicant is duly authorized to conduct business in the State of Colorado.
2. That the Applicant owns leasehold interests in the unit requested for pooling.
3. That pursuant to COGCC Orders established in Cause No. 139, specifically Order No. 139-8, a 320-acre drilling and spacing unit for the Williams Fork and Iles Formations of the Mesaverde Group (aka Mesaverde Formation) was established, which includes the following lands at issue in this Application (hereinafter "subject lands"):

Township 6 South, Range 93 West, 6th P.M.
Section 20: W/2

4. That pursuant to COGCC Order 139-47, the subject lands were approved for the for ten (10) acre density drilling for the Williams Fork Formation. Such order also provided that Williams Fork wells drilled upon the subject lands shall be drilled either vertically or directionally from no more than one pad located on a given quarter quarter section unless exception is granted by the Colorado Oil and Gas Conservation Commission pursuant to application made for such exception.
5. Applicant has proposed the drilling of the Overcracker Federal 20-14D well to be located on the SE/4SW/4 of the application lands ("subject well") to the Mesaverde Group.
6. The interested parties to this application are listed on Exhibit "A" attached hereto. As to those parties so listed which own unleased mineral interests in the subject lands, such parties have been offered the opportunity to participate in the drilling of the subject well or to lease their mineral interests. To date one or more of such parties have either elected not to participate in drilling of the subject well or to lease their interests or have not responded. As to

those parties which are lessees of lands within the drilling unit, such parties also have been offered the opportunity to participate in the drilling of the subject well. To date one or more of such parties have either elected not to participate in drilling or have not responded.

7. That in order to prevent waste, protect correlative rights and in the best interests of conservation, all interests owned by the non-consenting parties listed on Exhibit A should be pooled in the Williams Fork Formation and the Iles Formation in accordance with C.R.S. § 34-60-116 and Rule 530 of the COGCC.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice thereof be given as required by law and that upon such hearing this Commission enter its order:

A. That all unleased mineral interests who have elected not to lease or to participate in drilling of the subject well be pooled involuntarily with respect to the Williams Fork Formation and the Iles Formation and that such owners be treated as non-consenting owners under C.R.S. § 34-60-116 and made subject to the terms and penalties provided for therein. Likewise, all lessees in the drilling unit who have not elected to participate in the drilling of the subject well be pooled involuntarily with respect to the Williams Fork Formation and the Iles Formation and that such owners be treated as non-consenting owners under the same statutory provisions.

B. For such other findings and orders as the Commission may deem proper or advisable in the premises.
