APPLICATION

Orion Energy Partners, L.P. (“Applicant”), by and through its attorneys, Beatty & Wozniak, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado (the “Commission”) for an order establishing field rules applicable to the drilling and producing of wells from the Williams Fork Formation and Iles Formation of the Mesaverde Group covering certain described lands in Garfield County, Colorado and in support of its Application states and alleges as follows:

- 1. Applicant is a corporation duly authorized to conduct business in the State of Colorado.
- 2. Applicant owns leasehold interests or has rights to acquire leasehold interests in the following described lands:

Township 6 South, Range 91 West, 6th P.M.

- Section 4: Lots 8, 9, 12, S/2SE/4
- Section 7: S/2 SE/4, SE/4 SW/4
- Section 8: S/2, E/2 NE/4
- Section 9: W/2
- Section 12: S/2SE/4
- Section 13: W/2E/2, E/2SW/4
- Section 16: All
- Section 17: All
- Section 18: Lot 4, SE/4 NW/4, E/2 SW/4, E/2
- Section 21: SE/4 NW/4, SW/4 NE/4, NE/4 SW/4, NW/4 SE/4, E/2 SE/4
- Section 27: NW/4 NW/4
- Section 28: NE/4 NE/4

Garfield County, Colorado.

(hereafter the “Application Lands”).

- 3. That the majority of the Application Lands (with the exception of a portion of the lands in Sections 9 and 13) are subject to Order No. 513-3 which established 320-acre drilling and spacing units for the Williams Fork and Iles Formations of the Mesaverde Group and authorized well density of one (1) well per 20 acres to be drilled and completed for gas and associated hydrocarbons in each such 320-drilling and spacing unit and established setbacks of 200’ from the boundaries of the unit or lease line.
- 4. That with respect to all remaining Application Lands in portions of Sections 9 and 13, such Application Lands are currently subject to Commission Rule 318.a., which requires that wells drilled in excess of two thousand five hundred feet (2,500’) in depth be located not less than six hundred feet from any lease line, and located not less than one thousand two hundred feet (1,200’) from any other producible or producing oil or gas well when drilling to the same common source of supply, unless authorized by order of the Commission upon hearing.
- 5. That Applicant has drilled, tested and completed multiple wells in the Williams Fork Formation and the Iles Formation of the Mesaverde Group upon lands nearby to the Application Lands.

6. That to promote efficient drainage within the Williams Fork Formation and the Iles Formation of the Mesaverde Group in the Application Lands, the Commission should allow the option to drill up to one well per ten (10) acre density pattern for the Subject Lands. Applicant requests that well locations for such wells be no closer than one hundred (100') feet from the boundaries of the unit or lease line in unspaced areas where such well abuts lands which have previously been authorized to be drilled on a 10-acre density basis, otherwise such setbacks shall be 200' from said lease line or unit.

7. That the above-proposed density and well location rules will allow more efficient drainage of the Williams Fork and Iles Formations of the Mesaverde Group; will prevent waste; will not adversely effect correlative rights and will assure the greatest ultimate recovery of gas and associated hydrocarbon substances from the reservoir.

8. Applicant commits that wells to be drilled under this Application will be drilled from the surface either vertically or directionally from no more than one pad located on a specific quarter quarter section unless exception is granted by the Director of the Commission, and that both formations will be reached from a single wellbore. In this manner, the wells will be economic as to both formations.

9. That the names and addresses of the interested parties in this Application according to the information and belief of the Applicant are set forth in Exhibit A hereto, and that Applicant will submit a Certificate of Service of this Application on each interested party within the next seven days as required by Rule 503.d.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice be given as required by law and that upon such hearing this Commission enter its order consistent with Applicant's proposals as set forth above.
