APPLICATION

Rubicon Oil & Gas, LLC ("Applicant") by and through its attorney, Gretchen VanderWerf, PC, respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission") for an order establishing approximately 640-acre drilling and spacing units and establishing existing well location rules applicable to the drilling and producing of wells from the Codell and Niobrara Formations covering certain described lands in Weld County, Colorado and in support of its Application, Applicant states and alleges as follows:

1. Applicant is a corporation duly authorized to conduct business in the State of Colorado.
2. Applicant owns leasehold interests in the lands described in Exhibit B attached hereto and incorporated herein by reference (hereafter the "Application Lands").
3. Pursuant to Commission Rule 318.a., a well to be drilled to a depth of 2,500 feet or greater shall be located not less than 600 feet from any lease line, and shall be located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same source or supply, unless authorized by order of the Commission upon hearing. There are no other specific Commission orders applicable to the Codell Formation or the Niobrara Formation underlying the Application Lands.
4. The Codell Formation in this area is defined as the stratigraphic equivalent of the interval between 7950 feet and 7972 feet as found in the Borchert UPRR-Amoco 1-21 Well located in Township 9 North, Range 66 West, Section 21: SE $\frac{1}{4}$ SW $\frac{1}{4}$. The Codell Formation is a common source of supply underlying the Application Lands.
5. The Niobrara Formation in this area is defined as the stratigraphic equivalent of the interval between 7660 feet and 7950 feet as found in the Borchert UPRR-Amoco 1-21 Well located in Township 9 North, Range 66 West, Section 21: SE $\frac{1}{4}$ SW $\frac{1}{4}$. The Niobrara Formation is a common source of supply underlying the Application Lands.
6. To promote efficient drainage within the Codell and Niobrara Formations of the Application Lands, to protect correlative rights and to avoid waste, the Commission should

establish drilling and spacing units of approximately 640 acres as more particularly described in Exhibit B attached hereto and incorporated herein by reference.

7. The Applicant has drilled, tested and completed wells in the Codell and Niobrara Formations of the Application Lands.

8. The above-proposed drilling and spacing units will allow efficient drainage of the Codell and Niobrara Formations; will prevent waste; will not adversely affect correlative rights and will assure the greatest ultimate recovery of gas and associated hydrocarbon substances from the reservoirs. Drilling and spacing units of the size and shape specified above are not smaller than the maximum area that can be economically and efficiently drained by the proposed well in each such drilling and spacing unit.

9. The Applicant requests an order allowing it to drill and complete one horizontal well in each of the established 640-acre drilling and spacing units comprised of the Application Lands. The Applicant states that each proposed horizontal well shall be drilled in the designated drilling and spacing unit with initial penetration of the Codell and Niobrara Formations and an ultimate bottomhole location no closer than 600 feet from the boundaries of the drilling and spacing unit. The Applicant further maintains that the proposed horizontal wells will have no adverse effect on the correlative rights of adjacent owners.

10. The Applicant further states that the requested wells can be developed in a manner consistent with protection of the environment, public health, safety and welfare.

11. The names and addresses of the interested parties according to the information and belief of the Applicant are set forth in Exhibit A attached hereto and made a part hereof, and the undersigned certifies that copies of this Application shall be served on each interested party within the next seven days as required by Rule 503.e.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice be given as required by law and that upon such hearing, this Commission enter its order consistent with Applicant's proposals as set forth above.
