#### **APPLICATION**

COMES NOW Red Willow Production Company (referred to herein as "Applicant"), by and through its undersigned attorneys, respectfully submits this application to the Colorado Oil and Gas Conservation Commission ("Commission") for an order establishing a 719.02 acre drilling and spacing unit for the Fruitland Coal Seam Formation and to allow two (2) horizontal wells to be drilled within the enlarged drilling and spacing unit. In support thereof, the Applicant states and alleges as follows:

- 1. Applicant is duly authorized to conduct business in the State of Colorado.
- 2. This application concerns lands within the exterior boundaries of the Southern Ute Indian Reservation confirmed by Congress in 1984 under Public Law No. 98-290. Insofar as the Application Lands are subject to the jurisdiction of the Southern Ute Indian Tribe, this Application is submitted to this Commission in accordance with the terms of the Memorandum of Understanding dated August 22, 1991 between the Bureau of Land Management ("BLM") and this Commission and separate Memorandum of Understanding dated August 22, 1991 between the Bureau of Indian Affairs, the BLM, and the Southern Ute Indian Tribe.
- 3. Certain surface tracts and mineral interests under the Application Lands are owned in trust by the United States of America for the benefit of the Southern Ute Indian Tribe ("Trust Lands"). The minerals under those Trust Lands have been leased by the Southern Ute Indian Tribe to Red Willow Production Company under a mineral development agreement approved by the United States Department of the Interior, Bureau of Indian Affairs.
- 4. Applicant owns a majority leasehold interest in the following described lands (hereinafter "Application Lands"):

Township 32 North, Range 4 West, N.M.P.M.

Section 21: E½E½ Section 22: ALL Section 23: W½W½

Archuleta County, Colorado, containing 719.02 acres, more or less.

A reference map of the Application Lands is attached hereto as Exhibit B.

- 5. On May 8, 2008, the Commission entered Order No. 112-210 which vacated Order No. 112-85 and established drilling and spacing units, the allowable number of wells for each drilling and spacing unit, and setbacks for production from the Fruitland Coal Seam Formation horizontal wells for certain lands in Archuleta County, Colorado, including the Application Lands. Specifically, Order No. 112-210 established the following drilling and spacing units for the Application Lands:
  - A. "Spacing Unit #1"

Township 32 North, Range 4 West, N.M.P.M.

Section 21: E½E½ Section 22: W½

Archuleta County, Colorado, containing 359.02 acres, more or less.

B. "Spacing Unit #2"

Township 32 North, Range 4 West, N.M.P.M.

Section 22: E½
Section 23: W½W½

Archuleta County, Colorado, containing 360.00 acres, more or less.

Order No. 112-210 also allowed Spacing Unit 1 and Spacing Unit 2 to each have one (1) horizontal well per spacing unit, provided that the producing leg from any horizontal well have 660 foot setbacks from the outer boundary of another drilling and spacing unit.

- 6. To promote economical and efficient drainage, to protect correlative rights, to avoid waste, to reduce surface impacts, and to effectively recover gas and associated hydrocarbons from the Fruitland Coal Seam Formation for the Application Lands, Applicant requests that the Commission combine Spacing Unit 1 and Spacing Unit 2 and establish a 719.02 acre drilling and spacing unit and allow two (2) horizontal wells to be drilled and completed to the Fruitland Coal Seam Formation. Applicant asserts that the combining of Spacing Unit 1 and Spacing Unit 2 will allow the Fruitland Coal Formation to be efficiently drained due to the additional length available to each horizontal well on the Application Lands.
- 7. Applicant requests that the setbacks for the requested 719.02 acre drilling and spacing unit of the Application Lands remain at 660 feet from the outer boundary of another drilling and spacing unit as such setbacks will prevent waste, will protect correlative rights and will assure the greatest ultimate recovery of gas and associated hydrocarbon substances from the reservoir. Applicant asserts no producing leg of any horizontal well shall be closer than 660 feet from the unit boundary lines.
- 8. The surface location of the two (2) horizontal wells shall be located on an existing common or expanded well pad.
- 9. That the names and addresses of the interested parties according to the information and belief of the Applicant are set forth in <u>Exhibit A</u> attached hereto and made a part hereof, and the undersigned certifies that copies of this Application shall be served on each interested party within the next seven days as required by Rule 503.e.
- 10. The Southern Ute Indian Tribe, as a majority mineral interest owner in the Application Lands, is in support of this Application. Energen Resources Corporation also supports this Application.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice be given as required by law and that upon such hearing this Commission enter its order consistent with Applicant's proposals as set forth above.
