APPLICATION

COMES NOW Anadarko E&P COMPANY LP ("Applicant"), by its undersigned attorneys, and makes application ("Application") to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order establishing three drilling and spacing units for the production of oil and associated hydrocarbons from the Niobrara Formation and allowing the drilling of up to two (2) horizontal wells in each such unit. The proposed units are comprised of the following described lands in Weld County, Colorado:

DSU 1: Township 12 North – Range 65 West, 6th P.M.

Section 15: Lots 1-4

92.00 Acres

Section 22: All 640.00 Acres

Total: 732.00

DSU 2: Township 12 North – Range 65 West, 6th P.M.

Section 14: Lots 1-4

80.00 Acres

Section 23: All 640.00 Acres

Total: 720.00

DSU 3: Township 12 North - Range 65 West, 6th P.M.

Section 13: Lots 1-4

68.80 Acres

Section 24: All 640.00 Acres

Total: 708.80

(hereinafter "Application Lands")

In support of its Application, Applicant avers and states as follows:

- 1. That Applicant is a corporation duly authorized to conduct business in the State of Colorado and is a registered operator in good standing with the Commission.
- 2. That Applicant owns a substantial leasehold interest in the Niobrara Formation underlying the Application Lands.
- 3. The Application Lands, as to the Niobrara Formation are currently unspaced and are subject to Commission Rule 318.a. which provides that a well to be drilled in excess of two thousand five hundred (2,500) feet in depth shall be located not less than six hundred (600) feet from any lease line, and shall be located not less than one thousand two hundred (1,200) feet from any other producible or drilling oil or gas well when drilling to the same source of supply, unless authorized by order of the Commission upon hearing.
- 4. Based upon geological studies and horizontal drilling of the Niobrara Formation in the same general area of the Application Lands, Applicant asserts that the Niobrara Formation may produce economic volumes of oil when drilled and completed within horizontal wells.
- 5. That appropriate setbacks for the drilling of the two (2) exploratory horizontal wells within each drilling and spacing unit for the Niobrara Formation of the Application Lands should be as follows:
- (a) That the surface location may be located anywhere on the Application Lands or surrounding lands.
- (b) That the initial perforation, lateral and terminus of the horizontal wells within the Niobrara Formation shall be located no closer than 600 feet from the boundary of the established drilling and spacing unit.
- (c) That the lateral within the Niobrara Formation shall be located no closer than 600 feet from any other wellbore on the Application Lands which has perforated the Niobrara Formation.
- 6. That the proposed drilling and spacing units will allow more efficient development of the oil and gas resources within the Niobrara Formation, will prevent waste and will not violate correlative rights.
- 7. That the names and addresses of the interested parties according to the information and belief of the Applicant are set forth in Exhibit A attached hereto.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing in February 2011; that notice be given as required by law and that upon such hearing this Commission enter its order consistent with Applicant's proposals as set forth above.
