APPLICATION

COMES NOW Noble Energy, Inc. (referred to herein as "Applicant"), by and through its undersigned attorneys, and makes an application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission"), for an order establishing an 160-acre drilling and spacing unit for production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations comprised of the following lands:

Township 6 North, Range 62 West, 6th P.M. Section 18: NE¹/₄

Weld County, Colorado ("Application Lands").

In support thereof, the Applicant states and alleges as follows:

- 1. Applicant is a corporation duly authorized to conduct business in the State of Colorado and is a registered operator in good standing with the Commission.
- 2. Applicant owns substantial portion of the leasehold interests on the Application Lands.
- 3. The Application Lands are unspaced as to the Codell and Niobrara Formations and are subject to Rule 318A, which, among other things, established drilling windows and allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age Formation from the base of the Dakota Formation to the surface.
- 4. Applicant vertically drilled one (1) well on the Application Lands. The Wells Ranch AE18-17 ("Well") has surface and bottomhole location located 1203' FNL and 1370' FEL of Section 18, Township 6 North, Range 62 West. The Well is located within an established GWA drilling window. A Well Location Certificate is attached hereto.

- 5. Applicant requests that the Commission establish a 160-acre drilling and spacing unit for the Well on the Application Lands.
- 6. Applicant asserts that establishing the requested drilling and spacing unit for the Well, will allow for economic and efficient drainage of the Codell and Niobrara Formations; will prevent waste; will not adversely affect correlative rights and will assure the greatest ultimate recovery of gas and associated hydrocarbon substances from the reservoirs. An 160-acre drilling and spacing unit is not smaller than the maximum area that can be economically and efficiently drained by one (1) well in such unit.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice thereof be given as required by law and that upon such hearing this Commission shall enter its order:

- A. Establishing a 160-acre drilling and spacing unit upon the Application Lands.
- B. Granting any other relief as may be appropriate.
