APPLICATION

Carrizo Oil and Gas, Inc. ("Applicant"), by and through its attorneys, Beatty & Wozniak, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission") for an order creating a 640-acre drilling and spacing unit and authorizing up to thirteen horizontal wells in the following-described lands:

Township 11 North, Range 59 West, 6th P.M.
Section 31: All

Weld County, Colorado (the "Application Lands").

In support of its Application, Applicant states and alleges as follows:

1. Applicant is a corporation duly authorized to conduct business in the State of Colorado and is an operator in good standing with the Commission.
2. Applicant owns substantial leasehold interests in the Application Lands. A well location map of the Application Lands is attached as Exhibit A.
3. Applicant requests the right to drill up to thirteen horizontal wells in the Niobrara Formation in the proposed 640-acre drilling unit.
4. Applicant requests approval to drill, at its option, up to thirteen horizontal wells, in the proposed unit, with internal wellbores offset by 300 feet. Applicant also requests authorization to locate the "heel-and-toe" of the completed interval of the laterals no less than 100 feet from the unit boundaries perpendicular to the well laterals, while maintaining a 600 foot setback from the unit boundaries parallel to the well laterals.
5. Applicant asserts that the requested wells are necessary to prevent waste, protect correlative rights, and to assure the maximum efficient recovery of oil, gas and associated hydrocarbons from the Niobrara Formation on the Application Lands.
6. That in order to promote efficient drainage of the Niobrara Formation underlying the application lands, to prevent waste, and to protect correlative rights, the Commission should establish the drilling unit as requested herein and allow the drilling of up to thirteen horizontal wells

in said unit. The specified size and configuration of the requested drilling unit is not smaller than the maximum area that can be economically and efficiently drained by the requested well(s).

7. The names and addresses of the interested parties to this Application which include, as appropriate, offset operators, lessees, or mineral owners, are set forth in Exhibit B, and the undersigned certifies that copies of this Application shall be served on each interested party as required by Rule 503.e.

8. Applicant agrees to be bound by the oral order of the Commission.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, notice be given as required by law and that upon such hearing this Commission enter its order:

A. Establishing the requested drilling and spacing unit for production of oil, gas, and associated hydrocarbons from the Niobrara Formation.

B. Providing that Applicant may drill, at its option, up to thirteen horizontal wells, in the proposed unit, with internal wellbores offset by 300 feet.

C. Providing that the "heel-and-toe" of the completed interval of the laterals may be located no less than 100 feet from the unit boundaries perpendicular to the well laterals, while maintaining no less than a 600 foot setback from the unit boundaries parallel to the well laterals.

D. For such other findings and orders as the Commission may deem proper or advisable in the matter.
