AMENDED APPLICATION

Summary Statement: The Application original filed on April 18, 2013 sought an order to pool all interests in five designated wellbore spacing units for the drilling of the H-Y 29-21 Well, the H-Y 29-31 Well, the H-Y 29-31-8 Well, the H-Y 29-51 Well and the H-Y 29-52 Well. However, the H-Y 29-21 Well and the H-Y 29-31 Well were incorrectly identified as designated wellbore spacing units. These wells comprise two 80-acre drilling and spacing units under Commission Order No. 407-87 and is the basis for the Amended Application.

COMES NOW Great Western Operating Company, LLC ("Applicant"), by its attorneys, Beatty & Wozniak, P.C., and makes this **amended** application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order pooling all interests in the following described units for the development of the Codell-Niobrara Formation:

- a. **Two Order 407-87 80-acre drilling and spacing units for the H-Y 29-21 Well (API No. 05-123-35425), the H-Y 29-31 Well (API No. 05-123-35427) on the following described lands:**

Township 6 North, Range 67 West, 6th P.M.

Section 29: E $\frac{1}{2}$ NW $\frac{1}{4}$ (DSU #1 - 80-acres - H-Y 29-21 Well)

Section 29: W $\frac{1}{2}$ NE $\frac{1}{4}$ (DSU #2 - 80-acres - H-Y 29-31 Well)

- b. **Three approximate 160-acre wellbore spacing units for the H-Y 29-31-8 Well (API No. 05-123-35437), the H-Y 29-51 Well (API No. 05-123-35432), the H-Y 29-52 Well (API No. 05-123-35434) on the following described lands:**

Township 6 North, Range 67 West, 6th P.M.

Section 29: E $\frac{1}{2}$ NW $\frac{1}{4}$, W $\frac{1}{2}$ NE $\frac{1}{4}$ (WSU #1 - 160-acres - H-Y 29-31-8 Well)

Section 29: NE $\frac{1}{4}$ (WSU #2 - 160-acres - H-Y 29-51 Well)

Section 29: NW $\frac{1}{4}$ (WSU #3 - 160-acres - H-Y 29-52 Well)

Weld County, Colorado (**collectively referred to as** "the Application Lands").

In support thereof, Applicant states and alleges as follows:

1. Applicant is a limited liability company duly authorized to conduct business in the State of Colorado, and is a registered operator in good standing with the Commission.
2. Applicant holds the right to operate on the Application Lands.
3. On February 19, 1992, the Commission issued Order No. 407-87 (amended August 20, 1993), which among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with the permitted well locations in accordance with the provisions of Order No. 407-1.
4. On April 27, 1998, the Commission adopted Rule 318A, which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age Formations from the base of the Dakota Formation to the surface. On December 5, 2005, Rule 318A was amended to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended to, among other things, address drilling of horizontal wells. The Application Lands are subject to Rule 318A for the Codell-Niobrara Formation.

REQUEST TO POOL ALL INTERESTS IN TWO ORDER 407-87
80-ACRE DRILLING AND SPACING UNITS

5. Applicant, pursuant to Commission Rule 530 and/or the provisions of C.R.S. § 34-60-116 (6) and (7), hereby requests an order to pool all interests, including but not limited to, any nonconsenting interests, in the Application Lands for the development of the Codell-Niobrara Formation underlying the following **Order 407-87 80-acre drilling and spacing units**:

Township 6 North, Range 67 West, 6th P.M.

Section 29: E½NW¼ (DSU #1 - H-Y 29-21 Well)

Section 29: W½NE¼ (DSU #2 - H-Y 29-31 Well)

6. Applicant requests that the Commission's pooling order be made effective as of the earlier of the date of this Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of **the H-Y 29-21 Well in DSU#1, and the H-Y 29-31 Well in DSU#2** to the Codell-Niobrara Formation on the Application Lands.

7. That in order to prevent waste and to protect correlative rights, all interests in the **two Order 407-87 80-acre drilling and spacing units, DSU#1 and DSU#2**, should be pooled for the orderly development of the Codell-Niobrara Formation, including any nonconsenting interests therein.

**REQUEST TO POOL ALL INTERESTS IN THREE APPROXIMATE
160-ACRE WELLBORE SPACING UNITS**

8. Applicant designated **three approximate 160-acre wellbore spacing units for the H-Y 29-31-8 Well, the H-Y 29-51 Well, and the H-Y 29-52 Well**, as defined below, for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formation pursuant to Rule 318A. and notified the appropriate parties under Rule 318A.

9. Applicant, pursuant to Commission Rule 530 and/or the provisions of C.R.S. § 34-60-116 (6) and (7), hereby requests an order to pool all interests, including but not limited to, any nonconsenting interests, in the Application Lands for the development of the Codell-Niobrara Formation underlying the **following designated wellbore spacing units**:

Township 6 North, Range 67 West, 6th P.M.

Section 29: E $\frac{1}{2}$ NW $\frac{1}{4}$, W $\frac{1}{2}$ NE $\frac{1}{4}$ (WSU #1 - H-Y 29-31-8 Well)

Section 29: NE $\frac{1}{4}$ (WSU #2 - H-Y 29-51 Well)

Section 29: NW $\frac{1}{4}$ (WSU #3 - H-Y 29-52 Well)

10. Applicant requests that the Commission's pooling order be made effective as of the earlier of the date of this Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of **the H-Y 29-31-8 Well in WSU#1, the H-Y 29-51 Well in WSU#2, and the H-Y 29-52 Well in WSU#3** to the Codell-Niobrara Formation on the Application Lands.

11. That in order to prevent waste and to protect correlative rights, all interests in **the three approximate 160-acre wellbore spacing units, WSU #1, WSU #2, and WSU #3** should be pooled for the orderly development of the Codell-Niobrara Formation, including any nonconsenting interests therein.

12. Applicant certifies that copies of this Application will be served on all persons owning an interest in the mineral estate of the tracts to be pooled within seven (7) days of the date hereof, as required by Rule 507.b(2), and that at least thirty (30) days prior to the hearing on this matter, each such interest owner not already leased or voluntarily pooled will be offered the opportunity to lease, or to participate in the drilling of the Wells, and will be provided with the information required by Rule 530 as applicable. The list of such interested parties is attached hereto as Exhibit A.

WHEREFORE, Applicant requests that this matter be set for hearing at the next available opportunity, that notice be given as required by law, and that upon such hearing, the Commission enter its order:

A. Pooling all interests in the Application Lands and the **two Order 407-87 80-acre drilling and spacing units DSU #1 and DSU #2** for the development of the Codell-Niobrara Formation.

B. Providing that the Commission's pooling order is made effective as of the earlier of the date of this Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of **the H-Y 29-21 Well in DSU#1 and the H-Y 29-31 Well in DSU#2** to the Codell-Niobrara Formation on the Application Lands.

C. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of **the H-Y 29-21 Well and/or the H-Y 29-31 Well** are pooled by operation of statute, pursuant to C.R.S. § 34-60-116(6) and (7), and made subject to the cost recovery provisions thereof with respect to the drilling of **the H-Y 29-21 Well in DSU#1 and the H-Y 29-31 Well in DSU#2** to develop the Codell-Niobrara Formation comprising the Application Lands.

D. Pooling all interests in the Application Lands and the **three approximate 160-acre wellbore spacing units WSU #1, WSU#2 and WSU #3** for the development of the Codell-Niobrara Formation.

E. Providing that the Commission's pooling order is made effective as of the earlier of the date of this Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of **the H-Y 29-31-8 Well in WSU#1, the H-Y 29-51 Well in WSU#2, and the H-Y 29-52 Well in WSU#3** to the Codell-Niobrara Formation on the Application Lands.

F. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of **the H-Y 29-31-8 Well, the H-Y 29-51 Well and/or the H-Y 29-52 Well** are pooled by operation of statute, pursuant to C.R.S. § 34-60-116(6) and (7), and made subject to the cost recovery provisions thereof with respect to the drilling of **the H-Y 29-31-8 Well in WSU#1, the H-Y 29-51 Well in WSU#2, and the H-Y 29-52 Well in WSU#3** to develop the Codell-Niobrara Formation comprising the Application Lands.

G. For such other findings and orders as the Commission may deem proper or advisable in this matter.



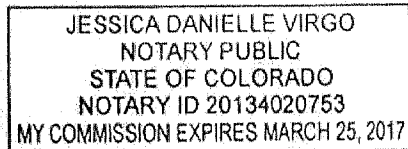
