APPLICATION

COMES NOW Noble Energy, Inc. ("Applicant"), by its attorneys, Beatty & Wozniak, P.C., and makes this application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order to pool all interests within two approximate 320-acre wellbore spacing units for the drilling of the Feuerstein I28-63-1HN Well, (API No. 05-123-36661), and the Feuerstein I28-64-1HC (API No. 05-123-36664) Well (collectively "Wells") for the development of the Codell and Niobrara Formations on the following described lands:

Township 6 North, Range 66 West, 6th P.M.

Section 28: S½ WSU#1 - Feuerstein I28-63-1HN – Niobrara Formation

Section 28: S½ WSU#2 - Feuerstein I28-64-1HC – Codell Formation

Weld County, Colorado (hereinafter "Application Lands").

In support thereof, Applicant states and alleges as follows:

1. Applicant is a corporation duly authorized to conduct business in the State of Colorado, and is a registered operator in good standing with the Commission.
2. Applicant owns certain leasehold interests in the Application Lands.
3. On April 27, 1998, the Commission adopted Rule 318A, which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age Formations from the base of the Dakota Formation to the surface. On December 5, 2005, Rule 318A was amended to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended to, among other things, address drilling of horizontal wells.
4. Applicant designated the two 320-acre wellbore spacing units, as defined below, for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations pursuant to Rule 318A. and notified the appropriate parties under Rule 318A.

5. Commission Order Nos. 381-1, 381-2 and 381-5 include the Application Lands, but do not apply and have no affect the Application as the Wells were designated as wellbore spacing units under Rule 318A.

6. Applicant, pursuant to Commission Rule 530 and/or the provisions of C.R.S. § 34-60-116 (6) and (7), hereby requests an order to pool all interests, including but not limited to, any nonconsenting interests, in the Application Lands in the Niobrara Formation underlying the following approximate 320-acre designated wellbore spacing unit:

Township 6 North, Range 66 West, 6th P.M.
Section 28: S½ WSU#1 - Feuerstein I28-63-1HN

7. Applicant requests that the Commission's pooling order be made effective as of the earlier of the date of this Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of the Feuerstein I28-63-1HN to the Niobrara Formation in WSU#1 on the Application Lands.

8 Applicant, pursuant to Commission Rule 530 and/or the provisions of C.R.S. § 34-60-116 (6) and (7), hereby requests an order to pool all interests, including but not limited to, any nonconsenting interests, in the Application Lands in the Codell Formation underlying the following approximate 320-acre designated wellbore spacing unit:

Township 6 North, Range 66 West, 6th P.M.
Section 28: S½ WSU#2 - Feuerstein I28-64-1HC

9. Applicant also requests that the Commission's pooling order be made effective as of the earlier of the date of this Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of the Feuerstein I28-64-1HC to the Codell Formation in WSU#2 on the Application Lands.

10. Applicant certifies that copies of this Application will be served on all persons owning an interest in the mineral estate of the tracts to be pooled within seven (7) days of the date hereof, as required by Rule 507.b(2), and that at least thirty (30) days prior to the hearing on this matter, each such interest owner not already leased or voluntarily pooled will be offered the opportunity to lease, or to participate in the drilling of each of the Wells, and will be provided with the information required by Rule 530 as applicable. The list of such interested parties is attached hereto as Exhibit A.

11. That in order to prevent waste and to protect correlative rights, all interests in the Feuerstein I28-63-1HN and WSU#1 should be pooled for the orderly development of the Niobrara Formation, including any nonconsenting interests therein.

12. That in order to prevent waste and to protect correlative rights, all interests in the Feuerstein I28-64-1HC and WSU#2 should be pooled for the orderly development of the Codell Formation, including any nonconsenting interests therein.

WHEREFORE, Applicant requests that this matter be set for hearing at the next available opportunity, that notice be given as required by law, and that upon such hearing, the Commission enter its order:

A. Pooling all interests in the Feuerstein I28-63-1HN and WSU#1 on the Application Lands for the development of the Niobrara Formation.

B. Providing that the Commission's pooling order is made effective as of the earlier of the date of this Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of the Feuerstein I28-63-1HN in WSU#1 to the Niobrara Formation on the Application Lands.

C. Pooling all interests in the Feuerstein I28-64-1HC and WSU#2 on the Application Lands for the development of the Codell Formation.

D. Providing that the Commission's pooling order is made effective as of the earlier of the date of this Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of the Feuerstein I28-64-1HN in WSU#2 to the Codell Formation on the Application Lands.

E. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Wells are pooled by operation of statute, pursuant to C.R.S. § 34-60-116(6) and (7), and made subject to the cost recovery provisions thereof with respect to the Well drilled to develop the Codell and Niobrara Formations in WSU#1 and WSU#2 comprising the Application Lands.

F. For such other findings and orders as the Commission may deem proper or advisable in this matter.


