APPLICATION

COMES NOW Great Western Operating Company, LLC (Operator No. 10110) ("Applicant"), by its attorneys, Jost & Shelton Energy Group, P.C., and makes this application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order to pool all interests within an approximate 1,175-acre drilling and spacing unit, for the development of the Codell-Niobrara Formation on the following described lands:

Township 6 North, Range 67 West, 6th P.M.

Section 19: SE1/4

Section 20: S½

Section 29: W½NW¼

Section 30: All

Township 6 North, Range 68 West, 6th P.M.

Section 25: SE¼NE¼

1,175 acres, more or less, Weld and Larimer Counties, Colorado. (hereinafter "Application Lands")

In support thereof, Applicant states and alleges as follows:

- 1. Applicant is a corporation duly authorized to conduct business in the State of Colorado, and is a registered operator in good standing with the Commission.
 - 2. Applicant owns certain leasehold interests in the Application Lands.
 - 3. Orders Applicable to all of the Application Lands.

- (a) On April 27, 1998, the Commission adopted Rule 318A, which among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age Formations from the base of the Dakota Formation to the surface. On December 5, 2005, Rule 318A was amended to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended to, among other things, address the drilling of horizontal wells.
- (b) On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formation underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order No. 407-1.
 - 4. Orders Applicable to Sections 19 and 30 of the Application Lands.
- (a) On January 7, 2013, the Commission entered Order No. 407-742, which 1) vacated the approximate 80-acre drilling and spacing units established by Order No. 407-87 for the SE¼ of Section 19 and all of Section 30, Township 6 North, Range 67 West, 6th P.M., 2) established an approximate 320-acre drilling and spacing unit consisting of the W½ of Section 30, Township 6 North, Range 67 West, 6th P.M., 3) established an approximate 480-acre drilling and spacing unit consisting of the SE¼ of Section 19 and the E½ of 30, Township 6 North, Range 67 West, 6th P.M., and 4) approved up to four (4) horizontal wells within each unit, for the development and operation of the Codell-Niobrara Formation, with the treated interval of the horizontal wellbores to be no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the treated interval of any other wellbore located in the unit, without exception being granted by the Director.
- (b) On September 16, 2013, the Commission entered Order No. 407-851, which approved up to twelve (12) horizontal wells within the approximate 480-acre drilling and spacing unit consisting of the SE $\frac{1}{4}$ of Section 19 and the E $\frac{1}{2}$ of 30, Township 6 North, Range 67 West, 6th P.M. for the development and operation of the Codell-Niobrara Formation, with the treated interval of the horizontal wellbores to be no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the treated interval of any other wellbore located in the unit, without exception being granted by the Director.
- (c) On September 15, 2014, the Commission entered Order No. 407-1104, which 1) vacated an approximate 320-acre drilling and spacing unit established by Order No. 407-742 for the W½ of Section 30, Township 6 North, Range 67 West, 6th P.M., 2) vacated Order No. 407-851 in its entirety, 3) corrected the acreage of the drilling and spacing unit consisting of the SE¼ of Section 19 and the E½ of 30, Township 6 North, Range 67 West, 6th P.M. to be approximately 450 acres, and 4) modified the drilling and spacing unit consisting of the SE¼ of Section 19 and the E½ of 30, Township 6 North, Range 67 West, 6th P.M. to allow only one horizontal well, the Raindance FD 19-21HN Well.

- 5. Orders Applicable to section 20 of the Application Lands.
- (a) On July 29, 2013, the Commission entered Order No. 407-835, which pooled all interests in an approximate 160-acre designated wellbore spacing unit established for the H-Y 20-54 Well (API No. 05-123-35429), covering the SE¼ of Section 20, Township 6 North, Range 67 West, 6th P.M., for the development and operation of the Codell-Niobrara Formation.
 - 6. Orders Applicable to sections 25 and 29 of the Application Lands.
- (a) As described above, Order No. 407-87 applies to Section 29, Township 6 North, Range 67 West, 6th P.M. and Section 25, Township 6 North, Range 68 West, 6th P.M. No other specific Commission orders apply to such lands.
- 7. Applicant has concurrently filed an application herewith, to be heard at the Commission's January hearing, which seeks to, among other things, 1) establish an approximate 1,175-acre drilling and spacing unit covering the Applications Lands and 2) authorize up to twenty-eight (28) horizontal wells in order to efficiently and economically recover the oil, gas and associated hydrocarbons within said 1,175-acre drilling and spacing unit from the Codell-Niobrara Formation.
- 8. Applicant, pursuant to Commission Rule 530 and/or the provisions of C.R.S. § 34-60-116 (6) and (7), hereby requests an order to pool all interests within the drilling and spacing unit, including but not limited to, any non-consenting interests and leased mineral interests, in the Application Lands in the Codell-Niobrara Formation underlying the following approximate 1,175-acre drilling and spacing unit:

Township 6 North, Range 67 West, 6th P.M.

Section 19: SE¹/₄ Section 20: S¹/₂

Section 29: W½NW¼

Section 30: All

Township 6 North, Range 68 West, 6th P.M.

Section 25: SE¼NE¼

- 1,175 acres, more or less, Weld and Larimer Counties, Colorado. (hereinafter "Application Lands")
- 9. Applicant requests that the Commission's pooling order be made effective as of the earlier of the date of this Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b) are first incurred for the drilling of any well to the Codell-Niobrara Formation in the Application Lands.
- 10. Applicant certifies that copies of this Application will be served on all persons owning an interest in the mineral estate of the tracts to be pooled, including leased mineral interest owners, within seven (7) days of the date hereof, as required by

Rule 507.b(2). The list of such interested parties is attached hereto as <u>Exhibit A</u>. Applicant is seeking pooling for the orderly development of the hydrocarbons underlying the Application Lands. At this time, Applicant is not seeking that the cost recovery provisions of C.R.S. § 34-60-116(7)(b) be applied to any non-consenting owners within the Application Lands, but reserves the right to do so at a later date if necessary.

- 11. That in order to prevent waste and to protect correlative rights, all interests in the drilling and spacing unit should be pooled for the orderly development of the Codell-Niobrara Formation, including any non-consenting interests therein.
- 12. This Application is being filed thirty-eight (38) days in advance of the hearing date for which Applicant proposes the matter be docketed, being January 26, 2015. Applicant has discussed the timing of submission of this Application with the Secretary and understands that there is docket availability. Thus, Applicant requests that the Secretary accept this Application pursuant to Rule 506.a. as there is docket availability and the notice requirements of Rules 507 and 508 can be met.

WHEREFORE, Applicant requests that this matter be set for hearing at the next available opportunity, that notice be given as required by law, and that upon such hearing, the Commission enter its order:

- A. Pooling all interests in an approximate 1,175-acre drilling and spacing unit established for the Application Lands for the development of the Codell-Niobrara Formation.
- B. Providing that the Commission's pooling order is made effective as of the earlier of the date of this Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b) are first incurred for the drilling of any well to the Codell-Niobrara Formation in the Application Lands.
- C. For such other findings and orders as the Commission may deem proper or advisable in this matter.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing in January 2015, that notice be given as required by law, and that upon such hearing, the Commission enter its order consistent with Applicant's request as set forth above.
