APPLICATION

Carrizo Oil & Gas, Inc. ("Carrizo"), by and through its attorneys, Burns, Figa, & Will, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission") for an order pooling all interests in an approximate 921.58-acre drilling and spacing unit established for the development of the Niobrara and Codell formations on the following described lands:

Township 1 North, Range 66 West, 6th P.M.
Section 34: ALL

Weld County, Colorado

Township 1 South, Range 66 West, 6th P.M.
Section 3: N/2

Adams County, Colorado; containing a total of approximately 921.58 acres
("Application Lands")

In support of its Application, Carrizo states and alleges as follows:

1. Carrizo is a corporation duly authorized to do business in Colorado and is registered as an operator in good standing with the Commission.
2. Carrizo is an owner with the right to drill into and produce from the Application Lands.
3. On April 27, 1998, the Commission adopted Rule 318A, which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age formations from the base of the Dakota formation to the surface. Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and

density requirements of Greater Wattenberg Area wells. On December 5, 2005, Rule 318A was amended, among other things, to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended, among other things, to address drilling of horizontal wells. The Application Lands are subject to Rule 318A for the Codell and Niobrara formations.

4. On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993), which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara formations, with the permitted well locations in accordance with the provisions of Order No. 407-1. The Application Lands are subject to Order No. 407-87 for the Codell and Niobrara formations.

5. On November 16, 1992, the Commission entered Order No. 499-15 which, among other things, established 320-acre drilling and spacing units for certain lands for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara formations commingled or dually-completed with the Dakota or "J" Sand formations. The Application Lands are subject to Order No. 499-15 for the Codell and Niobrara formations commingled with the Dakota or "J" Sand formations.

6. Carrizo makes this Application in conjunction with Amended Application 410-SP-2140 for an order to: (i) maintain the approximate 80-acre drilling and spacing units established for the Application Lands for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara formations; (ii) maintain the approximate 320-acre drilling and spacing units established for the Application Lands for the production of oil, gas, and associated hydrocarbons from existing wells producing from or completed to the Codell and Niobrara formations commingled or dually-completed to the Dakota or "J" Sand formations; (iii) establish an approximate 921.58-acre drilling and spacing unit for the Application Lands, for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara formations; and (iv) approve four (4) horizontal wells within the proposed unit, for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara formations.

7. Carrizo, pursuant to the provisions of C.R.S. § 34-60-116(6-7) and Rule 530, seeks an order pooling all interests, including, but not limited to, any nonconsenting interests, in the Application Lands for the development of the Niobrara and Codell formations.

8. Carrizo requests that the Commission's pooling order be made effective as of the earlier date of this Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of a horizontal well to the Niobrara and/or Codell formations on the Application Lands.

9. Carrizo certifies that copies of this Application will be served on all owners of the mineral estate, as indicated and required by Rule 507.b(2), underlying the Application Lands to be pooled within seven (7) days of the date hereof, and that at

least thirty-five (35) days prior to the hearing on this matter, each such interest owner not already leased or voluntarily pooled will be offered the opportunity to lease, or to participate in the drilling of the well, and will be provided with the information required by Rule 530. The list of such interested parties is attached as Exhibit A.

10. In order to prevent waste and to protect correlative rights, all interests in the Application Lands should be pooled for the orderly development of the Niobrara and Codell formations.

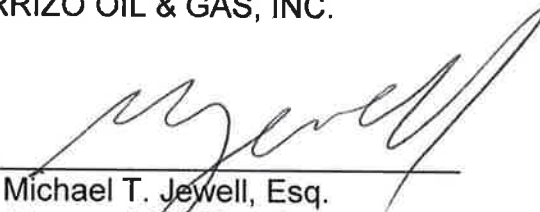
WHEREFORE, Carrizo respectfully requests that this matter be set for hearing at the next available opportunity, that notice be given as required by law, and that the Commission enter an Order to:

- A. Pool all interests in the Application Lands for the development of the Niobrara and Codell formations;
- B. Provide that the Commission's pooling order is made effective as of the earlier date of the Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of a horizontal well to the Niobrara and/or Codell formations on the Application Lands;
- C. Provide that the interests of any owners with whom Carrizo has been unable to secure a lease or other agreement to participate in the drilling of the authorized well(s) are pooled by operation of statute, pursuant to C.R.S. § 34-60-116(7), and made subject to the cost recovery provisions thereof with respect to all wells drilled to develop the Niobrara and Codell formations in the drilling unit comprised of the Application Lands;
- D. Provide for such other findings and order as the Commission may deem proper or advisable in this matter.
