APPLICATION

Extraction Oil & Gas, LLC ("Applicant"), by its attorneys, Gretchen VanderWerf, PC, applies to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order to pool all interests in twelve approximate 160-acre to 360-acre designated wellbore spacing units for the drilling of the Wind #1 through #12 Wells (the "Wells"), in Section 36, Township 5 North, Range 68 West, 6th P.M. and Sections 1 and 2, Township 4 North, Range 68 West, 6th P.M., for the development and operation of the Codell and Niobrara Formations.

In support of its application, Applicant states and alleges as follows:

- Applicant is a limited liability company duly authorized to conduct business in the 1. State of Colorado and is a registered operator in good standing with the Commission. Applicant's operator identification number is No. 10459
 - Applicant owns certain leasehold interests in the following described lands: 2.

- On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order No. 407-1.
- On April 27, 1998, the Commission adopted Rule 318A which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all Cretaceous Age Formations from the base of the Dakota Formation to the surface. On December 5, 2005, Rule 318A was amended, among other things, to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended, among other things, to address drilling of

horizontal wells. The Application Lands are subject to Rule 318A for the Codell and Niobrara Formations.

- 5. Applicant designated the twelve horizontal wellbore spacing units, as defined below, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations and notified the appropriate parties, pursuant to Rule 318A.
- 6. Applicant requests an order pursuant to C.R.S. §34-60-116(6) and (7) and Rule 530, for the pooling of all interests, including but not limited to, any nonconsenting interests and leased mineral interests in the Application Lands, for the development of the Codell and Niobrara Formations, as applicable, underlying the following designated horizontal wellbore spacing units ("Wellbore Spacing Units"):

- 7. Applicant requests that the Commission's pooling order be made effective as of the earlier of the date of this Application, or the date that the costs specified in C.R.S. §34-60-116(7)(b) are first incurred for the drilling of each of the Wells to the Codell and Niobrara Formations, as applicable, in the Wellbore Spacing Units on the Application Lands.
- 8. Applicant certifies that copies of this Application will be served on all persons owning an interest in the mineral estate of the tracts to be pooled, including leased mineral owners, within seven (7) days of the date hereof, as required by Rule 507.b(2), and that at least thirty (30) days prior to the hearing on this matter, each such interest owner not already leased or voluntarily pooled will be offered the opportunity to lease or to participate in the drilling of the Wells, as applicable, and will be provided with the information required by Rule 530. The list of the interested parties is attached hereto as Exhibit A.
- 9. That in order to prevent waste and to protect correlative rights, all interests in each of the Wellbore Spacing Units should be pooled for the orderly development of the Codell and Niobrara Formations, as applicable.

WHEREFORE, Applicant requests that this matter be set for hearing at the next available opportunity, that notice be given as required by law, and that upon such hearing, the Commission enter its order:

- B. Providing that the Commission's pooling order is made effective as of the earlier of the date of this Application, or the date that the costs specified in C.R.S. §34-60-116(7)(b) are first incurred for the drilling of each of the Wind #1 through #12 Wells in the Wellbore Spacing Units for the development of the Codell and Niobrara Formations, as applicable.
- C. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Wells are pooled by operation of statute, pursuant to C.R.S. §34-60-116(6) and (7), and made subject to the cost recovery provisions of the statute.
- D. Providing that the production obtained from the Wellbore Spacing Units shall be allocated to each owner in the unit on the basis of the proportion that the number of acres in such tract bears to the total number of mineral acres within the designated Wellbore Spacing Unit; each owner of an interest in the Wellbore Spacing Unit shall be entitled to receive its share of the production of the Well located on the Wellbore Spacing Unit, applicable to its interest in the Wellbore Spacing Unit.
- E. For such other findings and orders as the Commission may deem proper or advisable in this matter.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing in September 2015, that notice be given as required by law, and that upon such hearing, the Commission enter its order consistent with this Application.
