On January 31, 2005, EnCana Oil and Gas (USA) Inc. ("EnCana"), by its attorney, filed with the Commission a verified application for an order to increase the number of wells which can be optionally drilled into and produced from the lles Formation for the above-listed lands, the equivalent of one lles Formation well per 20 acres, with each well located downhole in the established drilling and spacing unit, no closer than 200 feet from the boundaries of the unit and no closer than 400 feet from any existing lles Formation well without exception being granted by the Director of the Oil and Gas Conservation Commission. EnCana commits that wells to be drilled under this Application will be drilled from the surface either vertically or directionally from no more than one well pad located on a given quarter quarter section unless exception is granted by the Director of the Colorado Oil and Gas Conservation Commission.

Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and nine (9) copies shall be filed with the Commission (Rule 503.f.). Anyone who files a protest or intervention must be available to participate in a prehearing conference during the week of March 7, 2005. Pursuant to Rule

503.e., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by March 7, 2005, the Applicant may request that an administrative hearing be scheduled for the week of March 7, 2005.
