NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On October 20, 1959, the Commission issued Order No. 112-6 which established 320-acre drilling and spacing units for the production of gas from the Mesaverde Formation underlying certain lands in the Ignacio-Blanco Field, with the permitted well to be located no closer than 990 feet from the boundaries of the quarter section. On July 16, 1979, the Commission issued Order No. 112-46 which amended Order No. 112-6 to allow the drilling of additional wells on each of the 320-acre drilling and spacing units for the production of gas from the Mesaverde Formation.

On November 22, 2005, Burlington Resources Oil & Gas Company LP (“Burlington”) by its attorney filed with the Commission a verified application for an order to pool the interests of SG Interests, Inc. and Red Willow Production Company in the 320-acre drilling and spacing unit consisting of the W½ of Section 4, Township 32 North, Range 11 West, N.M.P.M. for the development and operation of the Pictured Cliffs and Mesaverde Formations. The applicant proposes to drill its Ute 44 Well Pictured-Cliff/Mesaverde Well to the Pictured-Cliff and Mesaverde Formations underlying the W½ of said Section 4.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has scheduled the above-entitled matter for hearing on:

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than December 27, 2005, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and nine (9) copies shall be filed with the Commission (Rule 503.). **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of December 27, 2005.** Pursuant to Rule 503.e., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by **December 27, 2005, the Applicant may request that an administrative hearing be scheduled for the week of December 27, 2005.**
