#### NOTICE OF HEARING

#### TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On January 9, 2006, corrected February 28, 2006, the Commission issued Order No. 191-13, which among other things, established an approximate 260-drilling and spacing unit including the S½ of Section 18, Township 6 South, Range 92 West, 6<sup>th</sup> P.M., for the production of gas from the Williams Fork Formation of the Mesaverde Group.

On June 5, 2006, the Commission issued Order No. 191-25, which among other things, established an approximate 260-acre drilling and spacing unit including the  $S\frac{1}{2}$  of Section 18, Township 6 South, Range 92 West,  $6^{th}$  P.M., for the production of gas and associated hydrocarbons from the Iles Formation of the Mesaverde Group.

On May 22, 2006, Antero Resources Corporation, by its attorney, filed with the Commission a verified application for an order to pool all non-consenting interests in the approximate 260-acre drilling and spacing unit consisting of the S½ of Section 18, Township 6 South, Range 92 West, 6<sup>th</sup> P.M., for the development and operation of the Williams Fork and Iles Formations. The applicant plans to drill the Dever A-1 Well, Dever A-2 Well, Dever A-3 Well, and Dever A-4 Well in the S½ of said Section 18. Offers to lease or to participate have been made to the mineral owners or the leasehold owners but as of the date the application was filed, these attempts have been unsuccessful.

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than June 26, 2006, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and nine (9) copies shall be filed with the Commission (Rule 503.). Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of June 26, 2006. Pursuant to Rule 503.e., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by June 26, 2006, the Applicant may request that an administrative hearing be scheduled for the week of June 26, 2006. In accordance with Rule 511.b. of the Rules and Regulations of the Commission, if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the

supporting exhibits.
