NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

Rule 318.a. of the Rules and Regulations of the Commission requires that wells drilled in excess of two thousand five hundred (2,500) feet in depth be located not less than six hundred (600) feet from any lease line, and located not less than one thousand two hundred (1,200) feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. The below-listed lands are subject to this Rule:

On April 20, 2007, DJ Resources, Inc. ("DJ Resources"), by its attorney, filed with the Commission a verified application for an order to establish 40-acre drilling and spacing units for production of gas and associated hydrocarbons from the "O" Sand Formation, for below-listed lands:

Further, if the request to establish 40-acre drilling and spacing units is approved, DJ Resources seeks an order to pool all nonconsenting interests in the 40-acre drilling and spacing units consisting of the NE¼ SE¼ of Section 20, Township 9 North, Range 53 West, 6<sup>th</sup> P.M., for the development and operation of the "O" Sand Formation.

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

**In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than May 25, 2007, briefly stating the basis of the protest or intervention.** Such interested party shall, at the same time, serve a copy

of the protest or intervention to the person filing the application. An original and nine (9) copies shall be filed with the Commission (Rule 503.). **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of May 29, 2007.** Pursuant to Rule 503.f., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by **May 25, 2007, the Applicant may request that an administrative hearing be scheduled during the week of May 29, 2007.** In the alternative, pursuant to Rule 511.b., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
