NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

Rule 318.a. of the Rules and Regulations of the Commission requires that wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. Section 12, Township 7 South, Range 95 West, 6<sup>th</sup> P.M., is subject to this Rule for the Wasatch Formation.

On April 21, 2008, Williams Production RMT Company, by its attorney, filed with the Commission a verified application to establish four (4) approximate 160-acre drilling and spacing units for the below-listed lands for production of gas and associated hydrocarbons from the Wasatch Formation:

Township 7 South, Range 95 West, 6<sup>th</sup> P.M.

Section 12: NE $\frac{1}{4}$  (approximately 165.76 acres)  
Section 12: NW $\frac{1}{4}$  (approximately 162.87 acres)  
Section 12: SW $\frac{1}{4}$  (approximately 162.77 acres)  
Section 12: SE $\frac{1}{4}$  (approximately 165.83 acres)

Each Wasatch Formation well may be located anywhere in the drilling and spacing unit provided that it be drilled from a common surface location pad with Applicant's Williams Fork Formation operations within each drilling and spacing unit. The bottomhole of each Wasatch Formation well shall be no closer than 600' from the drilling and spacing unit boundaries.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has scheduled the above-entitled matter for hearing on:

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

**In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than May 27, 2008, briefly stating the basis of the protest or intervention.** Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and 13 copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of May 27, 2008.** Pursuant to Rule 503.f., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in

the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by **May 27, 2008, the Applicant may request that an administrative hearing be scheduled during the week of May 27, 2008.** In the alternative, pursuant to Rule 511.b., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
