On or about November 21, 2008, Williams Production RMT Company ("Williams"), by its attorney, filed with the Commission a verified application for an order to require Quantum Resources, LP ("Quantum") to provide gyroscopic surveys of downhole wellbore locations for the Wasatch and Williams Fork Formations in existing wellbores, contained in the below-listed lands, said request to allow for the efficient development of the Williams Fork Formation on adjacent and adjoining lands, approved for 10-acre well density, by Williams:

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than April 20, 2009, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and 13 copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 20, 2009.** Pursuant to Rule 503.f., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be

filed in this matter by **April 20, 2009, the Applicant may request that an administrative hearing be scheduled during the week of April 20, 2009.** In the alternative, pursuant to Rule 511.b., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
