NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On April 1, 2009, the Commission adopted Rule 305, which, among other things, requires the Director to promptly provide notification of the decision on an Application for Permit-to-Drill ("APD"), Form 2, or an Oil and Gas Location Assessment ("OGLA"), Form 2A, coupled with any conditions of approval, to the operator and to any party with standing to request a hearing before the Commission, pursuant to Rule 503.b. Said Rule further requires a party with standing to notify the Director, by written request setting forth the basis for any objection, within ten days of the issuance of the Director's decision, which shall result in the Director suspending the approval of the Form 2 or Form 2A, and the matter being set for an expedited adjudicatory hearing before the Commission.

On or about April 28, 2009, EnCana Oil and Gas (USA) Inc. ("EnCana"), filed an APD, Form 2, and OGLA, Form 2A, for the Bury Crandell #12-23 Well, located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 23, Township 1 North, Range 68 West, 6th P.M. On September 11, 2009, the Director issued the notice of decision on said Form 2 and Form 2A.

On September 21, 2009, Boa Sorte LP ("Boa Sorte"), by its attorney, filed a written objection to the issuance of the Form 2 and Form 2A for the Bury Crandell #12-23 Well on the basis that Boa Sorte has filed a qualifying surface development application, pursuant to §24-65.5-103.5, C.R.S., with the City and County of Broomfield regarding the placement of wells and directional drilling costs associated therewith.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has scheduled the above-entitled matter for hearing on:

In accordance with Rule 527., the parties are to participate in a prehearing conference before the hearings officer during the week of October 12, 2009, or at an earlier time as agreed to by the parties.
