HEARING TO CONSIDER APPLICATION FOR RULE-MAKING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

The Oil and Gas Conservation Commission has set a hearing to consider an application to amend Rule 905.b.(3)(A) filed by the Colorado Petroleum Association ("CPA") on March 10, 2010. Rule 905.b.(3)(A) currently requires synthetic liners to be removed and disposed in accordance with applicable legal requirements for solid waste disposal. Generally, CPA's petition proposes amendments that would allow pit liners to be buried in place, as exploration and production waste, based upon meeting several criteria.

At this hearing the Commission will consider whether, in its discretion to take action on the application pursuant to C.R.S. §24-4-103(7) (interested persons have a right to petition for rulemaking and action on such petition is within the discretion of the agency). A separate notice for rulemaking will be issued if the Commission determines to proceed with a rulemaking based on the application.

The Commission has statutory authority to consider the application for rulemaking pursuant to C.R.S. §§ 34-60-105 (power to make rules, regulations and orders to carry out the provisions of the Oil and Gas Conservation Act), 34-60-106(2)(d) (authority to regulate oil and gas operations to prevent and mitigate significant adverse environmental impacts), and 24-4-103(7) (agency has discretion to take action on petition for rulemaking by interested person).
