NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. Lot 1 and the NE¼ NW¼, W½ NE¼, and NE¼ NE¼ of Section 18, Township 7 South, Range 93 West, 6th P.M. are subject to this Rule for the Williams Fork Formation.

On July 23, 2007, the Commission issued Order No. 139-76, which among other things, established the equivalent of one well per 10 acres for certain lands, including Lot 1 and the NE¼ NW¼, W½ NE¼, and NE¼ NE¼ of Section 18, Township 7 South, Range 93 West, 6th P.M., for the production of gas and associated hydrocarbons from the Williams Fork Formation.

On November 23, 2009, Laramie Energy II, LLC ("Laramie"), by its attorneys, filed with the Commission a verified application for an order to establish an approximate 200.04-acre drilling and spacing unit consisting of Lot 1 and the NE¼ NW¼, W½ NE¼, and NE¼ NE¼ of Section 18, Township 7 South, Range 93 West, 6th P.M., for the production of gas and associated hydrocarbons from the Williams Fork Formation, and to pool all nonconsenting interests in said unit, for the operation and development of the Williams Fork Formation.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has scheduled the above-entitled matter for hearing on:

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than December 28, 2009, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and 13 copies shall be filed with the Commission. Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of December 28, 2009. Pursuant to Rule 503.f., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by December 28, 2009 the Applicant may request that an administrative hearing be scheduled during the week of December 28, 2009. In the alternative, pursuant to Rule 511., if the matter is uncontested, the applicant may request, and the

Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
