On April 30, 2011 COGCC Staff issued Notice of Alleged Violation ("NOAV") #200308970 to Coral for its operations at the Well. Said NOAV cited violations for various rules, including Rules 210.b., 210.d., 324A.a., 603.j., 604.a.(4)., 604.d., 902.a., 902.d., 902.g., 904., 906.a., 907.e., and 907.f.

The COGCC staff requests Coral be found in violation of Rules 210.b., 210.d., 324A.a., 603.j., 604.a.(4)., 604.d., 902.a., 902.d., 902.g., 904., 906., 907.e., and 907.f. for its operations at the Well.
