On October 31, 2011, the Commission entered Order No. 535-91 which, among other things, established two approximate 640-acre drilling and spacing units for certain lands and authorized up to two horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of the permitted wellbore to be located no closer than 600 feet from the boundary of the unit and no closer than 1200 feet from the treated interval of any other wellbore completed in the Niobrara, without exception being granted by the Director. Section 26, Township 8 North, Range 60 West, 6th P.M. is subject to Order No. 535-91 for the Niobrara Formation.

On May 10, 2012, Carrizo Oil & Gas, Inc. ("Carrizo" or "Applicant"), filed with the Commission, pursuant to § 34-60-116 C.R.S., a verified application ("Application") for an order to pool all interests in an approximate 640-acre drilling and spacing unit for the below-described lands ("Application Lands"), to accommodate the proposed Hemberger 1-26-34-8-60 Well (API No. 05-123-34430) ("Well"), for the development and operation of the Niobrara Formation, effective as of the earlier of the date of the Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b)(II) were first incurred for the drilling of the Well, and to subject any nonconsenting interests to the cost recovery provisions of C.R.S. § 34-60-116(7):

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than June 25, 2012, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and 13 copies shall be filed with the Commission. Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of June 25, 2012. Pursuant to Rule 503.g., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in

the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by **June 25, 2012, the Applicant may request that an administrative hearing be scheduled during the week of June 25, 2012.** In the alternative, pursuant to Rule 511., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
