On February 22, 2011, the Commission issued Order No. 535-3 which, among other things, established 160 approximate 640-acre drilling and spacing units, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, and approved one horizontal well within each unit, with the initial perforation and ultimate bottomhole location being no closer than 600 feet from the unit boundaries, without exception being granted by the Director. Section 29, Township 9 North, Range 58 West, 6th P.M. is subject to this Order for the Niobrara Formation.

On June 21, 2012, Noble Energy, Inc. ("Noble" or "Applicant"), by its attorneys, filed with the Commission pursuant to § 34-60-116 C.R.S., a verified application ("Application") for an order to:

- 1) modify Order 535-3 to vacate an approximate 640-acre drilling and spacing unit established for Section 29, Township 9 North, Range 58 West, 6th P.M.;
- 2) establish an approximate 320-acre drilling and spacing unit for the below-described lands ("Application Lands"); and
- 3) approve up to four horizontal wells and up to two vertical wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of the wellbore to be located no closer than 600 feet from the unit boundaries and no closer than 150 feet any existing or permitted oil or gas wellbore, without exception being granted by the Director:

Applicant confirms the E½ of Section 29, Township 9 North, Range 58 West, 6th P.M. will revert to unspaced land subject to Rule 318.a.

In accordance with Rule 509., any interested party desiring to protest the

granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than August 6, 2012, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and 13 copies shall be filed with the Commission. Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of August 6, 2012. Pursuant to Rule 503.g., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by August 6, 2012, the Applicant may request that an administrative hearing be scheduled during the week of August 6, 2012. In the alternative, pursuant to Rule 511., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
