AMENDED NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. Section 32, Township 12 South, Range 59 West, 6th P.M. and Section 5, Township 13 South, Range 59 West, 6th P.M. are subject to Rule 318.a. for the Marmaton, Cherokee, and Atoka Formations and Formations of the Mississippian, **Ordovician and Cambrian** Age.

On May 30, 2013 (Amended on September 19, 2013), Mustang Creek Operating, LLC ("Mustang Creek" or "Applicant"), by its attorneys, filed with the Commission pursuant to §34-60-116 C.R.S., a verified application ("Application") for an order to establish an approximate 635.6-acre exploratory drilling and spacing unit for the below-described lands ("Application Lands"), and approve **up to four wells** within the unit, for the production of oil, gas and associated hydrocarbons from Marmaton, Cherokee, Atoka Formations and Formations of Mississippian, **Ordovician and Cambrian** Age, with the treated interval of the permitted wellbore to be no closer than 600 feet from the unit boundaries, without exception being granted by the Director:

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than October 11, 2013, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. One electronic (cogcc.hearings unit@state.co.us), one original and two copies shall be filed with the Commission. Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 15, 2013. Pursuant to Rule 503.g., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by October 11, 2013, the Applicant may request that an administrative hearing be scheduled beginning October 15, 2013. In the alternative, pursuant to Rule 511., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
