## NOTICE OF HEARING

## TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On January 7, 2013, the Commission entered Order No. 407-741 which established an approximate 640-acre drilling and spacing unit, and approved up to seven horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formation. Section 16, Township 6 North, Range 67 West, 6<sup>th</sup> P.M. is subject to this Order for the Codell-Niobrara Formation.

On May 30, 2013, Great Western Operating Company, LLC ("Great Western" or "Applicant"), by its attorneys, filed with the Commission pursuant to C.R.S. §34-60-116, a verified application, Docket No. 1307-AW-40 ("Concurrent Application") for an order to approve up to twelve horizontal wells within an approximate 640-acre drilling and spacing unit established for Section 16, Township 6 North, Range 67 West, 6<sup>th</sup> P.M., for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formation.

On May 30, 2013, Great Western, by its attorneys, filed with the Commission pursuant to C.R.S. §34-60-116, a verified application ("Application") for an order to pool all interests in an approximate 640-acre drilling and spacing unit established for the below-described lands ("Application Lands"), for the development and operation of the Codell-Niobrara Formation, effective as of the earlier of the date of the Application, or the date that any of the costs specified in C.R.S. §34-60-116(7)(b)(II) were first incurred for the drilling of each of the Greenspire FD 16-22HN Well, the Greenspire FD 16-23HN Well, the Greenspire FD 16-34HC Well, the Greenspire FD 16-34HN Well, the Greenspire FD 16-36HN Well, the Greenspire FD 16-36HN Well, the Greenspire FD 16-37HC Well, the Greenspire FD 16-37HN Well, the Greenspire FD 16-38HC Well and the Greenspire FD 16-38HN Well ("Wells"), and to subject any nonconsenting interests to the cost recovery provisions of C.R.S. §34-60-116(7):

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than July 15, 2013, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. One electronic (cogcc.hearings unit@state.co.us), one original and two copies shall be filed with the Commission. Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 15, 2013. Pursuant to Rule 503.g., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the abovereferenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by July 15, 2013, the Applicant may request that an administrative hearing be scheduled beginning July 15, 2013. In the alternative, pursuant to Rule 511., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
