These Wells have not undergone the required Mechanical Integrity Testing ("MIT") two years after becoming Shut-in.

On December 5, 2013, Commission Staff issued five Notices of Alleged Violation ("NOAV's"), identified above in Table 1, to Wexpro citing violations of the following COGCC Rules of Practice and Procedure, 2 CCR 404-1 ("Rule" or "Rules"):

Rule 326.b.1 (Mechanical Integrity Testing Shut-In Wells).

COGCC staff requests that Wexpro be found in violation of rules cited above and assessed a penalty pursuant to Rule 523, and other relief as authorized by law.
