NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On February 27, 2014 (Amended March 25, 2014), Extraction Oil and Gas, LLC ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Pool all interests in three approximate 640-acre designated wellbore spacing units for the development and operation of the Codell and/or Niobrara Formations. All three units contain the same Application Lands.

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Winder #1 Well in WSU #1 to the Codell Formation, the Winder #2 Well in WSU #2 to the Niobrara Formation and the Winder #3 Well in WSU #3 to the Niobrara Formation (API Nos. TBD).

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 14, 2014.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing, based on review of the merits of the verified application and supporting exhibits.
