On February 27, 2014, Noble Energy, Inc. ("Noble" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Pool all interests in an approximate 640-acre designated wellbore spacing unit, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the NCLP PC AA04-62-1HN Well (API No. 05-123-37175).

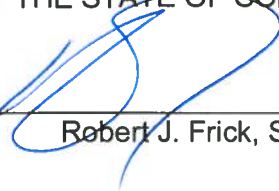

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of June 2, 2014.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing, based on review of the merits of the verified application and supporting exhibits.
