Sunburst is the operator of record of the Vader 33-15 Facility (No. 436012) ("Facility") in Larimer County. This Facility was not constructed in accordance with its approved Form 2A Permit.

On March 18, 2014, Commission Staff issued a Notice of Alleged Violation ("NOAV") No. 200399835 to Sunburst for violating a permit condition in violation of the Colorado Oil and Gas Conservation Act, ("Act"), § 34-60-121(1), C.R.S.

COGCC staff requests that Sunburst be found in violation of the statute cited above and assessed a penalty pursuant to Rule 523, and other relief as authorized by law.
