On April 17, 2014, Piceance Energy, LLC ("Piceance" or "Applicant") filed a verified application pursuant to §34-60-116 C.R.S. for an order to:

- 1) Vacate two approximate 320-acre drilling and spacing units established by Order No. 369-1 for the E½ and W½ of the Application Lands;
- 2) Establish an approximate 640-acre drilling and spacing unit for the Application Lands, for the production of oil, gas, and associated hydrocarbons from the Williams Fork and Iles Formations; and
- 3) Authorized the equivalent one (1) well per acres 10-acre density within the unit.
- Applicant states that all future permitted wells shall be located no closer than 100 feet from the boundary of the unit or lease line (if unspaced), unless exception is granted by the Commission. In cases where the Application Lands abut or corner lands where the Commission has not, at the time of the drilling permit application, granted the right to drill 10-acre density Mesaverde Formation or Iles Formation wells, the wells shall be located downhole no closer than 200 feet from the boundary or boundaries of the drilling unit or lease line (if unspaced) abutting or cornering such lands.
- 5) Applicant further states that the proposed unit will otherwise comply with the well location requirements of Order No. 399-4.

PRIOR RULES AND ORDERS (available online at: http://cogcc.state.co.us, under "ORDERS")

 On April 20, 1981, Order No. 369-1 established approximate 320-acre drilling and spacing units for the E½ and W½ of each section for the production of gas and associated hydrocarbons from the Mesaverde Formation; and the permitted well shall be at a location no closer than 600 feet to the boundaries of the unit. Section 25, Township 9 South, Range 93 West, 6th P.M. is subject to this Order.

 On February 25, 2005, Order No. 399-4 authorized the equivalent one (1) well per 10 acres for production of oil, gas and associated hydrocarbons from the Williams Fork and Iles Formations. Section 25, Township 9 South, Range 93 West, 6th P.M. is subject to this Order.
