On April 17, 2014, Bill Barrett Corporation ("BBC" or "Applicant") filed a verified application pursuant to §34-60-116 C.R.S. for an order to:

- 1) Maintain two approximate 640-acre drilling and spacing units established for the Application Lands for existing production of oil, gas and associated hydrocarbons from the Niobrara Formation:
- 2) Establish two approximate 1,280-acre drilling and spacing units for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations:
- 3) Approve up to 16 horizontal wells for the approximate 1,280-acre drilling and spacing unit to be established for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
- 4) Approve up to four horizontal wells for the approximate 1,280-acre drilling and spacing unit to be established for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Codell Formation;
- 5) Require the productive interval of the wellbore to be located no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit; and
- 6) Applicant requests to locate the surface facilities for the proposed wells on no more than five multi-well pads within the drilling and spacing unit.

- On February 22, 2011, Order Nos. 407-779 and 535-4 (corrected on April 4, 2013) established 74 approximate 640-acre drilling and spacing units, and approved one horizontal well for each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. Sections 25 and 26, Township 5 North, Range 62 West, 6th P.M. are subject to this Order.
