NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

APPLICATION

On April 15, 2014, Red Hawk Petroleum, LLC ("Red Hawk" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Establish an approximate 320-acre drilling and spacing unit for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
- 2) Approve up to four horizontal wells within the unit;
- 3) Require the productive interval of the wellbore to be located no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit;
- 4) Pool all interests in the proposed approximate 320-acre drilling and spacing unit for the development and operation of the Niobrara Formation; and
- 5) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of any well for which cost recovery is granted by the Commission at the June 16-17, 2014 hearing.

On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.

On April 5, 2013, the Commission entered Order Nos. 407-769 and 535-303 which, among other things, ordered that the E½ of Section 25, Township 6 North, Range 62 West, 6th P.M. is unspaced, subject to Rule 318A for well location, spacing and unit designation, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of June 2, 2014.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing, based on review of the merits of the verified application and supporting exhibits.
