- 1) Pool all interests in two approximate 480-acre designated horizontal wellbore spacing units established for the Application Lands, effective as of the date of the Application, for development and operation of the Niobrara Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of C.R.S. §34-60-116(7), for the drilling of the Steadfast E27-62-1HN well (API No. 05-123-38156) and the Healy E34-69HN well (API No. 05-123-38160).
