APPLICATION

On April 17, 2014, Red Hawk Petroleum, LLC ("Red Hawk" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Pool all interests, including previously unnoticed interests, in an approximate 1,280-acre drilling and spacing unit established by Order No. 535-9, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of any well for which cost recovery is granted by the Commission at the June 16-17, 2014 hearing.

3) On April 17, 2014, Red Hawk filed a concurrent application, Docket No. 1406-AW-15, pursuant to §34-60-116(4), C.R.S. for an order to approve up to fifteen horizontal wells within the unit. This concurrent application is set for hearing on June 16-17, 2014.

On April 4, 2011, the Commission entered Order No. 535-9 which established an approximate 1,280-acre drilling and spacing unit for Sections 1 and 12, Township 7 North, Range 62 West, 6th P.M. and approved one horizontal well within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.

On January 23, 2012, the Commission entered Order No. 535-133 which pooled all interests within the approximate 1,280-acre drilling and spacing unit.
