On April 17, 2014, Kerr-McGee Oil & Gas Onshore LP ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Pool all interests, including, but not limited to, any nonconsenting interests and leased mineral interests, in an approximate 520-acre designated horizontal wellbore spacing unit established for the Application Lands, for the development and operation of the Codell Formation, effective as of the date of the Application; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the NRC 3C-32HZ Well (API No. Pending).

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of June 2, 2014.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing, based on review of the merits of the verified application and supporting exhibits.
