APPLICATION

On April 17, 2014, Kerr-McGee Oil & Gas Onshore LP ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Pool all interests, including, but not limited to, any nonconsenting interests and leased mineral interests, in an approximate 240-acre designated horizontal wellbore spacing unit, for the development and operation of the Codell Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Banded 16C-27HZ Well (API No. Pending).
