## **APPLICATION**

On April 17, 2014, Kerr-McGee Oil & Gas Onshore LP ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests, including, but not limited to, any nonconsenting interests and leased mineral interests, in three approximate 480-acre designated horizontal wellbore spacing units, for the development and operation of the Codell and Niobrara Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Benson Farms 12C-23HZ Well (API No. Pending) ("WSU #1"), Benson Farms 33N-23HZ Well (API No. Pending) ("WSU #2") and the Benson Farms 13C-23HZ Well (API No. Pending) ("WSU #3").

On February 19, 1992, Order No. 407-87 (amended August 20, 1993) established 80-acre drilling and spacing units for the Codell and Niobrara Formations.

On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.

On March 17, 2014, the Commission entered Order Nos. 407-960, 407-961, 407-962, 407-963 and 407-964 which pooled all interests in certain designated wellbore spacing units including lands in Section 22, Township 3 North, Range 68 West, 6<sup>th</sup> P.M. These orders do not apply to and are not affected by this application.
