APPLICATION

On April 17, 2014, PDC Energy, Inc ("PDC" or "Applicant") filed a verified application pursuant to §34-60-116 C.R.S. for an order to:

1) Pool all interests in an approximate 320-acre wellbore spacing unit, effective as of the Application, for the drilling of the SunMarke 28U-334 Well, (API No. 05-123-38900), for the development and operation of the Niobrara Formation.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992, Order No. 407-87 (amended August 20, 1993) established 80-acre drilling and spacing units for the production of oil and/or gas from the Codell and Niobrara Formations underlying certain lands, with the permitted well locations in accordance with the provisions of Order No. 407-1.
- On May 29, 2012, Order No. 407-655 pooled all interests in three wellbore spacing units for the development and operation of the Codell and Niobrara Formations. Order No. 407-655 does not affect this Application.
- On November 15, 2012, Order No. 407-730 pooled all interests in a wellbore spacing unit for the development and operation of the Codell and Niobrara Formations. Order No. 407-730 does not affect this Application.
- On May 6, 2013, Order No. 407-785 pooled all interests in a wellbore spacing unit for the development of the Codell-Niobrara Formation. Order No. 407-785 does not affect this Application.

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado under §34-60-105 C.R.S.; 2) specific powers granted pursuant to §34-60-106 C.R.S.; 3) the State Administrative Procedures Act at §24-4-105 C.R.S.; and 4) the Commission's Series 500 Rules at 2 CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:
