#### APPLICATION

On April 17, 2014, Kerr-McGee Oil & Gas Onshore LP ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- Pool all interests, including previously unlocatable interests, in three approximate 480-acre designated wellbore spacing units, for the development and operation of the Niobrara and Codell Formations; and
- Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Reynolds Cattle 5C-23HZ Well (API No. 05-123-39138) to the Codell Formation ("WSU #1"), the Reynolds Cattle 31N-23HZ Well (API No. 05-123-39136) to the Niobrara Formation ("WSU #2") and the Reynolds Cattle 31C-23HZ Well (API No. 05-123-39133) to the Codell Formation ("WSU #3").

On February 19, 1992, Order No. 407-87 (amended August 20, 1993) established 80acre drilling and spacing units for the Codell and Niobrara Formations.

On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.

On April 28, 2014, the Commission entered Order No. 407-1013 which pooled all interests in three approximate 480-acre designated wellbore spacing units established for the Application Lands, for the development and operation of the Codell and Niobrara Formations.
