On April 17, 2014, Bill Barrett Corporation ("BBC" or "Applicant") filed a verified application pursuant to §34-60-116 C.R.S. for an order to:

- 1) Pool all interests in the approximate 320-acre horizontal wellbore spacing unit established for the Application Lands, effective as of the date of the Application, for development and operation of the Codell Formation;
- 2) Subject any nonconsenting interests to the cost recovery provisions of C.R.S. §34-60-116(7), for the drilling of the 70 Ranch 4-63-03-4856CDH well (API No. 05-123-37994), for development and operation of the Codell Formation; and
- 3) Subject any nonconsenting interests to the cost recovery provisions of C.R.S. §34-60-116(7), for the drilling of the 70 Ranch 4-63-03-4841CH well (API No. 05-123-37993) and the 70 Ranch 4-63-03-4956CH well (API No. 05-123-37925), for development and operation of the Niobrara Formation.
