APPLICATION

On April 17, 2014, Kerr-McGee Oil & Gas Onshore LP ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Pool all interests, including, but not limited to, any nonconsenting interests and leased mineral interests, in two approximate 720-acre designated horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Codell and Niobrara Formations, effective as of the date of the Application; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Hansen State 1N-36HZ Well (API No. 05-123-39194) to the Niobrara Formation ("WSU #1") and the St. Acacius State 41C-36HZ Well (API No. Pending) to the Codell Formation ("WSU #2").
