APPLICATION

On April 17, 2014, Kerr-McGee Oil & Gas Onshore LP ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Howard Federal 40N-22HZ Well (API No. 05-123-38235).

On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.

On October 28, 2013, the Commission entered Order No. 407-892 which pooled all interests an approximate 480-acre horizontal wellbore spacing unit established for the Application Lands ("WSU #5"), for development and operation of the Niobrara Formation. Order No. 407-892 did not subject nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the Howard Federal 40N-22HZ well.
