APPLICATION

On April 17, 2014, Ward Petroleum Corporation ("Ward" or "Applicant") filed a verified application pursuant to §34-60-116 C.R.S. for an order to:

- 1) Pool all interests in an approximate 640-acre drilling and spacing unit for the Application Lands, for the development and operation of the Codell Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of C.R.S. §34-60-116(7), effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Sharp #24-3-11HC well (API No. 05-001-09801) and Sharp #24-3-9HC well (API No. 05-001-09802) to the Codell Formation.

- On April 17, 2014, Applicant filed with the Commission a verified concurrent application ("Concurrent Application"), Docket No. 1406-SP-2072, for an order to establish an approximate 640-acre drilling and spacing unit for horizontal well development for the Codell and Niobrara Formations, and to approve up to 12 horizontal wells within the unit.

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of June 2, 2014.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing, based on review of the merits of the verified application and supporting exhibits.
