On March 19, 2015, Bonanza Creek Energy Operating Company LLC ("Bonanza" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Approve an additional 30 horizontal wells, for a total of up to 32 horizontal wells within an approximate 640-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation; and
- 2) Require the productive interval of the wellbore to be located no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On January 23, 2012, the Commission entered Order No. 407-538, establishing eight approximate 640-acre drilling and spacing units for the certain lands in Townships 4 and 5 North, Range 62 and Township 4 North, Range 63 West, 6th P.M., and authorizing up to two horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.
- On January 7, 2013, the Commission entered Order No. 407-740, which among other things, approves the request for an order to affirm the previous spacing Order No. 407-538 as to the previously unnoticed interested parties, and approve up to ten wells within eight approximate 640-acre drilling and spacing units Sections 1, 2 and 12, Township 4 North, Range 63 West, 6th P.M., Section 5, Township 4 North, Range 62 West, 6th

P.M. and Sections 17, 21, 29 and 31, Township 5 North, Range 62 West, 6th P.M., for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.
