APPLICATION

On March 19, 2015, Cirque Resources LP, Operator No. 10470, ("Cirque" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Maintain the approximate 640-acre drilling and spacing units established for Sections 28 and 33, Township 12 North, Range 66 West, 6<sup>th</sup> P.M., for the production of oil, gas and associated hydrocarbons from the Codell Formation;
- 2) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Codell Formation;
- 3) Approve up to three horizontal wells within the unit; and
- 4) Require the productive interval of the wellbore to be located no closer than 300 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit, without exception by the Director.
- 5) Applicant states that it is not seeking to modify production payments from the Railey #28-3-1CH Well (API No. 05-123-39863) which was drilled on Section 28, Township 12 North, Range 66 West, 6<sup>th</sup> P.M. or include production from this well into the proposed approximate 1280-acre drilling and spacing unit.
